Some History of Leo Norred Park

Leo Norred Park. This park is considered a Neighborhood Park. It is in the Okaloosa County Park listing: <http://www.co.okaloosa.fl.us/pw/parks/list>. We also have the Poquito Boat Ramp Park which is an Okaloosa County Bayou park.

Leo Norred Park History. PBCA has no historical records on the origin of Leo Norred Park. So I decided to talk with Tommy Norred, the son of the late Leo Norred. His father was one of the builders in this subdivision. He bought the triangle parcel around 1964. He was in the process of developing the property when the county told him that he had to reserve this parcel of land for a neighborhood park. For over 30 years, it was known as the triangular park. (Tommy also revealed why some houses on Poplar had sidewalks in front of them and other homes did not. The county kept changing its' mind on sidewalks as the community added more and more homes.)

People are always asking me why we are maintaining Leo Norred Park if it is a county park. The county owns the park, but PBCA currently maintains it, while the county pays for the insurance. I think I found the origin of this arrangement.

PBCA was formed in the spring of 1996. While reviewing some of the original PBCA meeting minutes I found the answer. In the first meeting recap, the late Mary Rush wrote: *"At the meeting a lively discussion centered around people being upset with the poor condition of our roads, speeding cars and commercial vehicles, drivers not stopping at posted stop signs; of disgust over conditions at the boat ramp park and lack of care for the little triangular park along Poquito Road rendering it unsuitable for use by anyone. We spoke of bayou-related boating, wave-runner, swimming safety, pollution and damage to the environment caused by heavy storms, hurricanes, and unaware people. Unleashed dogs were an issue, as was easement and mailbox vandalism, etc."*

Several years later, things started to happen with the PBCA stepping forward: a well was dug, and sprinkler system installed. Fencing was later added to three sides of the park. In 2003, PBCA renamed the park Leo Norred Park. (cont'd on page three)

Ramon Torres

It was sad to hear of the loss of Ramon Torres, who passed away on December 3rd, 2020. Like many of the Poquito Bayou residents, he was retired from the US Air Force. Ramon and his wife Nora were very active in the crucial beginnings of the PBCA community association. In the original PBCA meeting minutes, it shows that Ramon was the Street Director for West Poquito and Nora was Treasurer along with Pat Hollarn. I asked Pat Hollarn about Ramon and his contributions to PBCA. She replied: "Ramon was one of the "originals" and a good one. He worked with me to get that "arm" of Poplar closed completely, as the stop sign never worked and not only did people not pay attention to any cars on Magnolia, they ran the stop sign too. After a year or maybe two, Ramon's job and family (he was very active with the children's sports) took over, but he always supported us." The family still served our community over the years as they would pick up trash along Sunset and Poquito Road. I attended Ramon's service. It was a nice tribute to a wonderful man. We're going to miss Ramon.

President's Corner cont'd:

Kiki was the driving force in organizing the Christmas Caravan. We had over 50 kids! Some came from Niceville and even Crestview as well as our local neighborhood. This year we had a Santa that sported a real beard! Many thanks to Jackie Schmid for recruiting Santa. Santa has agreed to be part of our 2021 Christmas Caravan!! Many thanks for those who participated and helped with the logistics of making this a successful event. For those neighbors, whose street(s) were bypassed, it was over concern of too long a distance for the kids. We are certainly considering all the streets this next Christmas.

New PBCA Board Members. In early November Kiki Higginbotham joined the PBCA board. She has taken over the PBCA Children's Coordinator position. I have already mentioned how Kiki did an outstanding job with organizing the Christmas decorating at Leo Norred Park and the Christmas Caravan. In addition, Kiki is our new events coordinator. She's come up with some great events ideas for 2021. She has written an article that can be found in this Poquito Times. She's also helping with part of our website webmaster duties. In late October, Keith Meyers approached me asking to be a PBCA board member. I immediately asked Keith to take over the Poquito Bayou Boat Ramp Park Coordinator. I felt it was a perfect match. He's very concerned about our shoreline and quality of the water. Keith is going to work on getting multiple agencies to work together with issues at the park. Then Keith asked to take over the Poplar Street Director. We appreciate Kiki and Keith stepping up to the plate!

On December 18th Tracey Phillips and her husband Brian drove around and chose the winners of our Poquito Bayou Christmas Decorations contest. The winners of the contest are posted in this publication.

Leo Norred Park History cont'd

The Veteran's Memorial was unveiled in November 2007. Our County Commissioner at the time, John Janazzo attended this ceremony. He lauded our community association and our neighborhood for its efforts to work together for the greater good of all. Shortly afterwards things started to happen. PBCA Jane Fedosky went before the Okaloosa County Commissioners and asked if the county could install playground equipment. In 2008, after much cajoling on the part of the PBCA, the County installed playground equipment, along with sidewalks,



a pavilion, and a port-a-john. Some good intentioned residents had put up several of the old tire swings that we as youngsters used to enjoy. However, they did not meet county and OSHA park standards, so the county removed them and hauled them away. People were upset but it is a county park and safety was the major consideration

Then PBCA President Janet Guzalak went to an Okaloosa County Commissioner's meeting and asked what it would take to get swings that meet OSHA standards. We reached an agreement where the county would install the swings, but PBCA would pay for the rubber material around the swings. PBCA provided the county \$1500 to pay for the rubber material. The county was surprised that a community was willing to share costs. So, the county came in did all that was necessary for the park to have proper swings.

Over the years, a butterfly garden was created, we added lights for more security both in the park and in the pavilion, and an irrigation system was installed by PBCA volunteers. The flag was moved behind the Veteran's Memorial. Recently in response to request from the PBCA, the county added gravel in the parking area to cover some muddy parking areas.

Bill Miller oversees Leo Norred Park maintenance.

He views the park as an extension of his front yard. **He has done an outstanding job staying on top of park maintenance!** We have lawn maintenance on contract to mow when the grass needs to be cut. Your PBCA dues money contributes to the maintenance and upkeep of Leo Norred Park. PBCA members help maintain the park. What would have happened if we (PBCA) had not taken steps to improve the park? If the county took over the mowing and maintenance, we could never count on the park being ready for our events. There would be no fence around the park. Our maintenance of the park adds to the unique relationship we have with the county regarding overall park upkeep. At the time the park was established the county was not putting in irrigation systems or providing any other maintenance than mowing. The Boat Ramp Park is mowed every week or so and trash removed. If there's tree or light issues, we must call the county. We are working with the county and other state & federal agencies regarding the shoreline erosion.

We are also looking for an Emergency Action Chairperson.

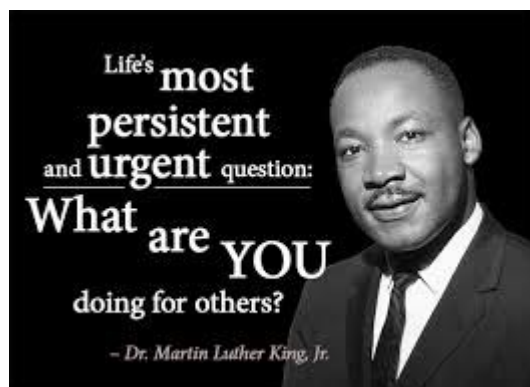

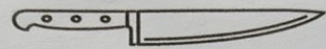
