COVID VACCINATIONS

Who is eligible? According to <http://okaloosa.floridahealth.gov/programs-and-services/infectious-disease-services/covid-19-vaccine.html#2>: All Floridians are eligible to receive the COVID-19 vaccine as prescribed by the FDA. This includes persons 16 years of age and older (Pfizer-BioNTech) or 18 years of age and older (Moderna or Johnson & Johnson). Any individual who is not 18 years of age or older by the day of their vaccination appointment must be accompanied by a parent/guardian to the vaccination clinic. Unaccompanied minors cannot be vaccinated and will be turned away from the vaccination clinic

Back in February I mentioned about making COVID-19 vaccine appointment for Jane and myself. I waited for several weeks and didn't get a call back. I decided to pre-register online. That was a very frustrating experience: timing out past the 15-minute time-period without selecting the register button. Jane gave me a phone number to call (850-344-0566) and I talked with a real person who took down all our details and made us an appointment the following day! I printed out some blank COVID-19 Vaccine Screening and Consent forms to fill out. Our vaccinations were given at the 221 Hospital Drive, N.E. in Fort Walton Beach. The process was very well organized. We were directed where to go every step of the process. The only reaction were sore arms. We provided our Florida Driver's license along with our forms and medical ID cards at the appropriate times. Our follow-up vaccine was March 17th. We had to fill out the forms again. The process was just like the first time. Our arms hurt more with the second shot. I typed "COVID shots in Okaloosa county Florida" in my web browser and it listed a plethora of places where one can get a COVID shot. Locations included: Publix, Winn Dixie, CVS, SAMS Club and other places.

As I was preparing my email note to the PBCA Board, I checked the March 2020 financial statement for PBCA dues and contributions year to date. Meeting with County Officials on improvements to Leo Norred Park and the Poquito Boat Ramp Park.

I understand this is little lengthy but believe it is worth your time to check out. On April 5th, Keith Myers, my wife Jane and I, met with Butch Hendrick, Okaloosa County Facilities and Parks Maintenance Director and his assistant Amanda Maxwell. Our focus was on three areas: 1. Four-way stop and road leading into the Poquito Bayou Subdivision; 2. Leo Norred Park and 3. Poquito Boat Ramp Park. We provided a detailed bullet paper on key concerns improving these areas. Our focus was on the Poquito Boat Ramp Park.

We briefly addressed the road leading into The Poquito Bayou Subdivision, from the four-way stop leading into the Poquito Bayou Subdivision. It lacks appeal. We asked what can be done to help remedy the appearance leading up to the entrance into the Poquito Bayou Subdivision. I mentioned that this may involve coordination between Bob Hope Enlisted Village and Eglin AFB in addition to the county. I told them that one PBCA member wants to have landscaping at the intersection of Sunset & Poquito Road (four-way stop) to improve the appearance. (at his expense)

At Leo Norred Park, we addressed a plethora of issues. There's no sign at Leo Norred Park stating that it's a county park and a list of restrictions (no pets, alcohol, vehicles, glass bottles, etc.). I stated that there's a misconception that the neighborhood owns Leo Norred Park. I addressed the issue of more parking posts on the left side of Leo Norred Park parking area to keep vehicles from driving into Leo Norred Park. We discussed our concerns about kids wandering out onto Poplar Ave from the children's playground area. We asked that four to five extra green and brown metal benches be added between playground equipment and the fence to help parents stop kids from wandering off. We told them that we were going to have some benches built on the other side of the playground area. We showed them the wear around the protective padding around swing set and playground equipment needs to be repaired or replaced. We asked to replace concrete tables and benches with picnic tables. They can easily topple over and break. We recently had one situation where a bench collapsed, and a young child had to go to the ER for stitches. There was some discussion regarding things for teenagers. In the end, we asked for anything the other county parks have that we didn't have.

At the Poquito Boat Ramp Park, we recommend that more gravel needs to be added along the sides of Bay Street leading down to the Boat Ramp Park. We asked that the parking area be repaved and striped. We requested more signs to prevent motorists from parking on the sidewalk. In addition, we requested that some signs be painted onto the pavement. Frequently we can't swim down by the boat ramp due to high fecal matter content. We asked if the county could work with the Health Department in determining if the fecal matter content from testing is animal or human? We pointed out some erosion where a concrete pad was removed that needs to be addressed. There are several "Restricted area- Restoration in progress" signs in the swimming area need to be removed since the core log" project is no longer there.

In addition, we proposed and/or recommended the following:

- A Kayak launch area and jet ski slides.
- The county apply for permit to add sand to beach area once the dock extension project is complete.
- More “No wake” area signs (that are used in the Hands Cove area) with the Corps of Engineers.
- Improve the parking area by upgrading the white poles and repaint them.
- We needed more Trash cans chained to “No Parking“ signs where boats egress and unload from water.
- A swim rope with buoys from end of New dock to existing- former swim rope pole.
- Request a sub service lease agreement.
- Design and implement Master Drainage plan to include retention pond area for existing low-lying area.
- Work with Choctawhatchee Basin Alliance (CBA) to further curtail shoreline erosion and improve restoration efforts through grant from Okaloosa county.
- Re-distribute signs throughout park for better access to public and to also improve aesthetics of boat ramp and park.
- Repair downed and twisted signs.
- Improve and re-sign Handicapped accessible area.

I sent our detailed bullet paper to Butch Hendrick and he appreciated our inputs. He was going to meet with our County Commissioner, Carolyn Ketchel the next day. I’m hoping that our meeting and detailed list helped. Time will tell.

Our favorite yards on Holly are 35, 37 and 39. These are great every year! On Maple, 34 and 43, look fantastic.

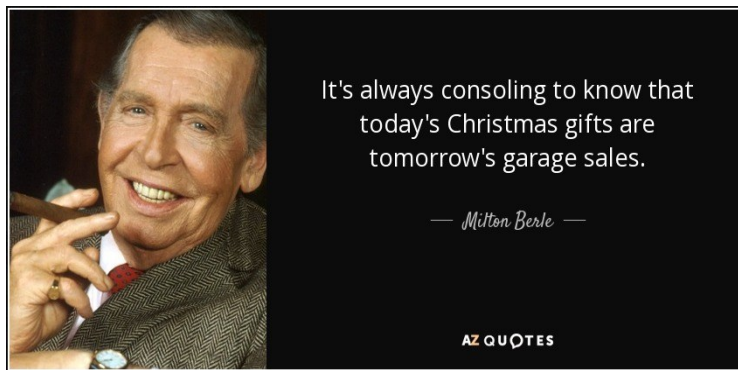
7 Maple is our runner up. It has beautiful grass and new beds with plants and flowers along the house and around the mailbox. Great job from these hard-working homeowners.

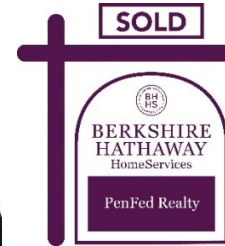
